Revised Policy for Management and Use of Community Halls including Fee Structure and Operationalization of Ancillary Facilities in Multi-Purpose Community Halls

Authority vide Minutes of meeting No. F.2(3)2024MC/DDA/63 dated 19.08.2024 of Authority meeting held on 06.08.2024 approved the agenda Item No. 37/2024 regarding Policy for Management and Use of Community Halls including Fee Structure and Operationalization of Ancillary Facilities in Multi-Purpose Community Halls. This policy would supersede the existing policies issues by various departments of DDA; from time to time, pertaining to booking of community halls. The present policy provides:

- Community halls/ Open function spaces/ Utsav Sthal for Online booking by DDA.
- Operationalization of Multipurpose Community Halls on License Basis.
- Operationalization of low occupancy Community Halls on License basis.

Overview of the existing structure

At present, there are 155 community halls, the break-up of which is as follows:

I. POLICY FOR COMMUNITY HALLS/ OPEN FUNCTION SPACES FOR ONLINE BOOKING

At present, there are two kinds of Facilities in DDA Community Halls viz.

- a. Function Hall Facility along with open space in the Community Halls where Social Functions are held.
- b. Multi-Purpose Community Halls with Ancillary Facilities such as Gym, Senior Citizen Center, Indoor Games, Yoga, Reading room.

1. Categories of community Halls

The community halls are categorized on the basis of locality into 3 categories as follows:

1.1 UTSAV STHAL

The policy for Community halls/ Open function spaces for Online booking would be applicable for Utsav Sthal also. The booking of Utsav Sthal during the festive season for Ramleela, Janamasthami, Dussehra, Durga Puja & Navratras, where joyrides, stalls, are traditionally set up, may be extended upto 45 days.

However, in case of Ramleela, the SOP dated 04.07.2024 shall be applicable.

2. Booking Methodology and Charges

The Function halls and open spaces will be booked through online booking portal of DDA, on First Come First Serve (FCFS) basis.

Booking can be made 120 days in advance till one prior working day of the date of event.

3. Security Deposit:

The Booking person shall have to deposit a security deposit equal to the booking amount

4. Cleaning Charges:

Cleaning during booking period of the allotment shall be the responsibility of the allottee. In addition to the Booking charges mentioned above, the cleaning charges shall be as follows:

5. Concession for DDA staff:

The rate of booking for DDA Staff shall be 50% of the Community Hall rates for general public. The 50% rebate would be applicable for the staff and immediate family members, which would include spouse, parents, children and unmarried real brothers & sisters. Proxy booking will not be permitted and will invite penal and disciplinary action as per conduct rules.

6. Check – in time

Check-in time shall be 12:00 Noon whereas Check-out Time shall be 10:00 am. For example, one Day booking for 1st July shall be admissible from 12:00 noon 1st July to 10:00 am on 2nd July.

7. Penal Rates

Penal rates at double the rate of the booking charges, will be applicable if the applicant does not vacate the premises within the booking time period. Further, cost of removal of structure and damage to DDA property, if any will be recovered from the applicant.

8. Cancellation Charges:

If no. of days between Date of Cancellation intimation, and the first day of booking are -	Cancellation Charges, as a percentage of booking amount
More than or equal to 30 days,	20%
Less than 30 days, but more than or equal to 07 days	50%
Less than 07 days	100%

9. Waiver of Cancellation Charges:

In case of death of immediate family member (i.e. spouse, parents, children, real brother and real sister) of the person who has made the booking. Cancellation charges may be waived with the approval of Superintending Engineer of the zone concerned on production of death certificate.

10. Refund of security

- a. Security deposit shall be refunded ONLINE within 15 days from the last date of booking.
- b. In case of forfeiture of security deposit (in part/full) due to violation/damage if any, the concerned SE (HQ) shall record the reasons for the same online and the same shall be communicated to the applicant through e-mail.
- c. In case of refunds, GST can be refunded by GST department and necessary NOC shall be furnished by DDA in this regard.

11. Maximum Booking

Maximum number of days for which a person shall be allowed to book the Community Hall, at a time shall be 5 days. No additional period for erecting / removal of tents etc. shall be given. An Applicant can make maximum 2 bookings in a calendar year.

12. Other terms and conditions

Other terms and conditions will be applicable as mentioned in the policy for streamlining of the procedure and Fee Structure for Temporary allotment of Open Spaces/ Community halls of the DDA for various functions dated 05.12.2019 as applicable for community halls.

II. POLICY FOR OPERATIONALIZATION OF ANCILLARY FACILITIES IN MULTI PURPOSE COMMUNITY HALLS

The Multipurpose Community Halls shall be categorized in two types for the purpose of allotment:

- A. **Multipurpose Community Halls allotted to RWAs (where cost of construction has been proportionally taken from allottees of Housing Scheme).**
- B. **Multi-purpose Community Halls on license basis (which are not the part of Housing Scheme).**

A. MULTIPURPOSE COMMUNITY HALLS ALLOTTED TO RWAs

1. Multipurpose Community Halls where cost of construction has been proportionally taken from allottees at the time of allotment of flats shall be handed over to concerned RWA. RWA would be given three opportunities to submit its proposal for taking over the Multipurpose Community Hall.
2. In case the RWA/RWAs fail to take over the Multipurpose Community Hall after three opportunities provided over a total period of six months, then the Multipurpose Community Hall will be taken over by DDA.
3. If there are more than one RWAs registered with Registrar of Co-operative Societies operating in a Housing Scheme, the allotment of Community Hall shall be done in favour of RWA which has maximum members.
4. RWA should be registered with DDA. For registration, the following documents are to be submitted online & Director (IL) in turn shall verify the uploaded documents of the RWA and after verification, forward the same for registration to Director (System). The documents required for registration are as under:
 - a. Applications signed by the executive officer of the Society.
 - b. Registration certificate with Delhi Government.
 - c. Memorandum/Bye laws of RWA.
 - d. Proposal for registration of RWA in DDA.
 - e. Copy of ID proofs of the governing body of RWA.
5. In case of any change in the constitution of RWA, the RWA shall intimate the same to Director/IL, DDA.

B. MULTIPURPOSE HALLS ON LICENSE BASIS

- a. In the Multipurpose Community Halls which are not a part of Housing Scheme, the function hall shall be booked by DDA online for social functions and multipurpose hall shall be given on License basis.
 1. All ancillary facilities in one MPCH shall be *bundled together* for the e- auction. Any agency participating in the e-auction will have to take up all the facilities (available for license) in the Multi-Purpose Community Hall. For example, if a bidder wishes to bid for a Community Hall available on license basis for library and gym, he/she will have to take up and bid for both the facilities (i.e. Library and Multi Gym) in the said Community Hall.
 2. The premises can be used by the licensee only for the purpose specified in letter of acceptance. The allowed usage for the said sites shall be for the said purposes only.

3. The premises will be given on license on "AS IS WHERE IS BASIS".
 4. Other terms and conditions will be applicable as mentioned in the auction document.
 5. Vice Chairman may amend the said other Terms and Conditions / Procedure for e-auction from time to time.
- b. The list of Multipurpose Community Halls to be auctioned on license basis is attached at Annexure-B.
 - c. Facilities that the Licensee shall have to create/operate and Services it will be required to provide are listed below. In case Licensee wishes to provide any other service in the facility, it shall obtain the consent of DDA before doing so.

Types of ancillary activities permissible in Multipurpose halls

In order to ensure proper utilization of these multipurpose halls, following activities will be permitted:

- a. Multi gym facility
- b. Reading room
- c. Senior citizens room
- d. Indoor games
- e. Food Kiosk
- f. Bank ATM
- g. Yoga Room

A brief overview of the activities expected to be carried out in the multipurpose halls is listed below

- a. **Multi Gym facility**
 - Cardio-vascular Equipment
 - Strength Training Equipment
 - Fitness Accessories
 - Additional Services: May offer a variety of additional programs and services, such as nutrition advice, weight loss challenges, lifestyle seminars, Yoga, Pilates, personal training, etc.
 - Vending Machines for water/ Refreshments.
- b. **Reading room**

Reading room shall have following facilities:

Space for users : The reading room should have

- A social space/ common room for interaction and knowledge exchange
- A quiet space for reading

The licensee shall, as far as possible, develop and create spaces for users.

Subscribe to a minimum of 10 popular Magazines and Newspapers each, in either Hindi or English to cater to the needs of the community.

Online Reading material (optional): Relevant Reading material / resources available online may be made available in the Reading room. The Reading room may tie up with other libraries to share resources.

Working hours: Reading room shall be open on all days including weekends and holidays with a weekly day off during week-day. The services shall be opened from 08:00 am to 10:00 pm.

Availability of supervisor

Vending Machines for water/ Refreshment: The reading room should offer a vending machine for the users to avail clean drinking water and healthy refreshments.

c. Senior Citizen Recreation Center

Spaces for users: Senior Citizen Recreational Centre should have to keep up with following spaces to attract a diversity of visitors.

- (a) A social space for interaction and knowledge exchange/ recreation.
- (b) A quiet space for contemplation/ meditation/ Yoga.

Recreational Facilities: The Senior Citizen Center should have facilities of Music player, Karaoke, Table, Chess Table, and similar other recreational facilities.

Medical Services: Licensee shall provide services of First Aid at the Centre. In addition, it will provide automatic B.P Machine, Glucometer, and such basic medical devices.

Lifestyle Services: Regular Yoga services may also be provided by the Licensee. Educational talk by experts, Taxation related services, etc. maybe provided.

Working hours: Senior citizen room shall be open on all days including weekends and holidays with a weekly day off during week-day. The services shall be opened from 10:00 am to 05:00 pm.

Refreshment: Pre-cooked food, tea/ coffee, refreshments, baked items etc. may be provided. No cooking activity shall be permitted.

d. **Indoor Games Room**

Any or all of the following indoor games facilities can be established.

- Billiards/ Snooker/ Pool
- Table Tennis
- Carrom
- Chess
- Board Games
- Children's

games

(No card games will be permitted)

e. **Food Kiosk**

1. The food kiosk/outlet would sell pre-packaged Milk and pre-packaged dairy products such as Ghee, Paneer, Butter, Flavored Milk, Ice Cream etc. as offered in milk booths.
2. Pre-cooked snacks, tea, coffee, baked items etc. is also permitted.
3. No cooking activity shall be permitted at the venue.

f. **Bank ATM**

1. The space would be used for setting up Bank ATM as per norms and specifications as prescribed by the concerned regulating authority.
2. It shall be ensured that all safety norms are complied with.
3. Provisions such as electric connection, wiring, required power load etc. shall be taken care of by the Licensee.
4. All the requisite permissions from the regulatory and sanctioning authorities for setting of an ATM will be taken by the Licensee.
5. Enabling provisions will have to be provided in MPD, for running the same.

g. **Yoga Room**

Space for users: Yoga room should have to keep up with following spaces to attract a diversity of visitors.

- A social space for Yoga under a trained yoga practitioner
- A quiet space for contemplation/ meditation

Medical Services: Licensee shall provide services of First Aid at the Centre. In addition, it should provide automatic B.P Machine, Glucometer and such basic medical devices.

Lifestyle Services: Health and nutrition services may also be provided. Practitioner of AYUSH may be appointed to provide AYUSH services.

Working hours: Yoga room shall be open on all days including holidays with a weekly day off.

Refreshment: Pre-cooked food, tea/ coffee, refreshments, baked items etc. may be provided. No cooking activity shall be permitted.

III. POLICY FOR E-AUCTION OF COMMUNITY HALL ON LICENSE BASIS

- a. The e-Auction of Community Halls on license basis will be implemented in such community halls where the bookings in the last one year have been less than 10.
- b. The Community Halls along with open spaces will be e-auctioned for 5 years on license basis. The tenure of 5 years will enable the private agency to make initial investment required to popularize the community Halls.
- c. The site can be used by the licensee only for the purpose of organizing marriages, socio-cultural functions, exhibitions, educational talks, Poetry Reading, Health related events.
- d. Activities Not Permitted: The Community Hall and the open space shall not be used for running Restaurant, Bar, Retail sale of goods or services, Movie Theatre, Offices (except office to manage the premises), Clubs.
- e. The premises can be used by the licensee only for the purpose as specified in letter of acceptance. The allowed usage for the said sites shall be for the said purposes only.
- f. The premises will be given on license on "AS IS WHERE IS BASIS".
- g. Naming of the Facility: The Licensee can name the Facility as per his choice / Branding. However, the ownership of DDA will be clearly mentioned.
- h. License fee shall be fixed as may be decided by Vice Chairman, DDA.
- i. Other terms and conditions will be applicable as mentioned in the auction document.
- j. Vice Chairman may amend the said other Terms and Conditions / from time to time.
