During the meetings held under the Chairmanship of Hon'ble Lt. Governor with the Vice Chairman, DDA on 30.08.2023 and with all stakeholders on 31.08.2023 in respect of booking of Open Spaces for organizing Ramlila, the following decisions were taken: -

- Security Deposit: The rates of the Security Deposit be restricted to Rs. 20 per Sqm. i)
- ii) Cleaning Charges: Cleaning charges shall remain the same as modified in Revised Fee Structure dated 13.07.2023 i.e. Rs. 2.75 per Sqm.
- (iii Religious Recreational: The setting up of stalls, Joyrides etc. would be permitted up to 40% of total booked area. Remaining area will be utilized for Ramlila purposes.
- iv) Bookings of ground for Ramlila purposes by various religious committees will be done by DDA as per list provided by 'Delhi Dharmik Mahasangh' (Federation of such Religious Committees).

In view of the foregoing decisions, it is hereby directed that in respect of the open spaces booked for organizing Ramlila in 2023, Security deposit and Cleaning charges as mentioned above shall be recovered and Joyrides, Stalls, etc., will be permitted upto 40% of the total booked area. The remaining area will be utilized for Ramlila purposes. Bookings of ground for Ramlila purposes by various religious committees will be done by DDA as per list provided by 'Delhi Dharmik Mahasangh' (Federation of such Religious Committees). The aforesaid directives shall apply specifically to the organization of Ramlila functions only in 2023. All other terms and conditions shall remain the same as per the existing policy in this regard. 07/09/23
