Sub: Policy Regarding booking of DDA Open Spaces for religious purpose during Saaya days.

The Vice Chairman, DDA has been pleased to relax the provisions of the current policy which precludes the booking of listed Open Spaces for religious or any other purpose during the Saaya days.

The requests have been coming from religious organizations/groups/societies to hold religious functions at DDA open spaces/sites which have not been booked for any marriage during Saaya days neither this year nor in the previous year and that the same should be allowed for religious function booking under free category i.e. no charge should be levied except security deposit.

Considering the genuine need and demand from various social and religious groups for holding the religious functions which may clash during the Saaya days, it has been decided to allow the religious society /organizations/social groups to book the DDA's open spaces/sites as per the conditions mentioned below:

(1) The religious society /organizations/social groups may book DDA's sites online, 15 days prior to the commencements of their functions/events for a period of a maximum of 07 days (seven days) during Saaya days and the booking may be allowed subject to availability of the site requested if it has no prior booking for marriage function. This arrangement has been allowed as the venues for marriage functions are booked 15 days prior to the date of event and otherwise those sites usually remain un-booked for marriage functions.


(2) No single society/religious organizations/social groups shall be allowed to book same site for more than once during Saaya days in a calendar year.

(3) The bookings for religious purposes as per (1) and (2) above shall be allowed under free category during Saaya days subject to deposit of Security Deposit and as per the other terms and conditions of the existing policy.

(4) It is to be noted that marriage/socio cultural functions on marriage sites/venues shall be first priority and religious booking on marriage site during Saaya days cannot be made earlier than 15 days from the date of function as mentioned above.

The above mentioned Clarification w.r.t the policy may please be implemented with immediate effect.

All concerned are requested to take immediate action accordingly for the smooth implementation of the above mentioned clarification in the policy.
