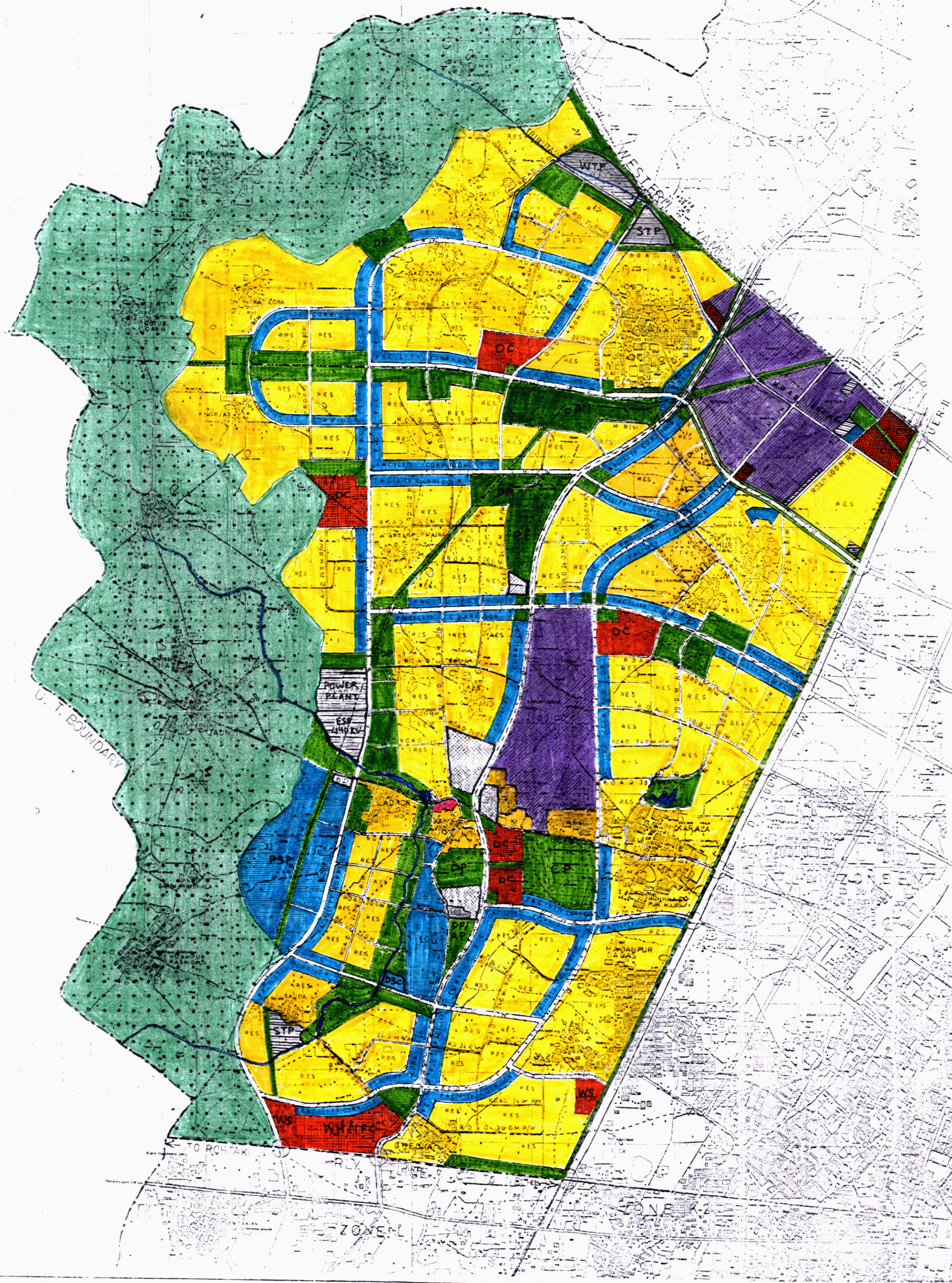


LANDUSE PLAN
