With reference to the Policy for Streamlining of the Procedure and Fee Structure for Temporary Allotment of Open Spaces/Community Halls of the DDA for various functions the following clarification are being issued: -

In light of the DPCC directions dated 13.12.2019 booking in open spaces may be allowed subject to the following conditions:-

1. No cooking of food & dish washing will be allowed in stalls.
2. Applicant is required to upload undertaking in attached Performa that DPCC direction dated 13.12.2019 will be complied with.
3. If the applicant violated DPCC direction dated 13.12.2019 than a penalty of Rs. 10,00,000/- will be imposed on the applicant (this amount of Rs.10,00,000/- will be charged at the time of booking itself and will be refunded along with the security deposit.)

The above mentioned clarification w.r.t the policy may please be imposed with immediate effect.

All concerned are requested to take immediate action accordingly for the smooth implementation of the above mentioned clarification to the policy.
