

No objections received beyond the prescribed time period and/or through means other than the portal shall be considered.

Kind attention of landowners of aforementioned List B is requested, they may submit their land parcels on the DDA web portal link (<https://online.dda.org.in/landpooling/AppForm/landpoolreg.aspx>) within 45 days from the date of issue of this Public Notice or may become the part of consortium or both (as applicable) otherwise it shall be considered at later stage as per clause 5(VII) of the Land Pooling Regulation, 2018.
