PROVISIONAL NOTICE FOR FORMATION OF CONSORTIUM

INVITATION TO FORM CONSORTIUM IN SECTOR-10A IN ZONE-N, SECTOR-2 IN ZONE P-II, SECTOR-3 IN ZONE P-II UNDER NOTIFIED LAND POLICY

It is hereby informed, that based on the applications received on the DDA web portal inviting expression of willingness for participation under Land Pooling Policy, **Sector -10A in Zone-N, Sector-2 in Zone P-II, Sector-3 in Zone P-II** and verified by Tehsildar / Nodal officer, GNCTD is likely to meet the eligibility criteria as per clause 4(III) of the Land Pooling Regulations 2018 and is being processed for initiating Consortium formation process and planning under the Land Policy notified on 11.10.2018.

In accordance with Policy and Regulations of Land Pooling notified vide S.O 5220(E) dated 11-10-2018 and S.O. 5384 (E) dated 24.10.2018, a Consortium has to be formed among the applicants/land owners of the qualifying sector. Accordingly, the land owners/applicants falling in **Sector-10A in Zone-N, Sector-2 in Zone P-II, Sector-3 in Zone P-II** are hereby informed to form a Consortium of each sector separately and apply online to DDA as a single entity, within 90 days of issuance of this notice, on DDA Land Pooling web portal <https://online.dda.org.in/landpooling/AppForm/default.aspx>. However, it may be noted that approval of scheme for land pooling would be subject to fulfillment of condition of 70% contiguous land at the time of submission of implementation plan. The details of the registered applicants duly verified by Tehsildar/Nodal Officer, GNCTD falling in **Sector-10A in Zone-N, Sector-2 in Zone P-II, Sector-3 in Zone P-II** and unpooled land of the mentioned sectors are available on above mentioned DDA website link.

Land Owners/Consortium of these sectors may encourage the non-participating land owners to participate, for seamless development of these sectors. List of Khasra nos. village wise is given on above mentioned DDA website, wherein land owners have not shown willingness to participate. Further, the details can be seen on Notice Board of Land Pooling Office, Pitampura, Opposite TV Tower, Delhi-110088.
