#### **MPD-2041: ONLINE PUBLIC CONSULTATION WITH REPRESENTATIVES FROM INDUSTRIES & INDUSTRIAL ASSOCIATIONS**

Delhi Development Authority (DDA) in association with the National Institute of Urban Affairs (NIUA), is preparing the next Master Plan of Delhi 2041. As part of the planning process, a series of discussions and consultations are being carried out with various stakeholders and civil society groups to seek their inputs towards driving the agenda of the Master Plan. So far a series of meetings have been held with Resident Welfare Associations, Market Trader Associations, Real-Estate Sector, Informal Sector and Youth of the City etc.

**The next public consultation meeting is scheduled on Friday, 27<sup>th</sup> November 2020 (11 am onwards) with Representatives from Industries, Chambers of Commerce and Industry Associations comprising of industries from manufacturing, services (knowledge based and high tech), construction, hotel and MICE industry and others.**

The objective of this meeting is to understand and discuss challenges and possible solutions wrt industrial development in Delhi.
